Statistical Analysis in European Project EVINCI

Description of the required task:

The work will be carried out in the context of two Work Packages (WPs) of European Project FP7 – EVINCI and should be completed no later than 9 (nine) months after the contract starting date;

- WP1: to build up a novel prediction model to establish pre-test probability of IHD (Ischemic Heart Disease) based on combined clinical data and biomarkers;
- WP5: to develop a new predictive model of outcome in patients with suspected IHD based on combined clinical-biomarkers-imaging information.

The new developed predictive model will allow the comparison of differnt of diagnostic strategies
