Franca Bimbi is Full Professor of Sociology, holder of Sociology Chair at University of Padua, Department of Philosophy, Sociology, Education and Applied Psychology (FISPPA). She represents the Director of Department FISPPA in the Board of the Interdepartmental Centre of Research and Studies on Gender Policies of the University (CRSPG) and in the Board of the Interdepartmental Centre of Research on Family (CIRF). She is member of the Scientific Committee of FISPPA.

She is member of the Board of the Doctoral School in Social Sciences where she was the Director until March 2012. At the Doctoral School she gives Seminars on Pierre Bourdieu, Intersectionality, Family Changes and Family Politics in EU, Gender and Migration Studies, Violence Against Women and Gender Violence, Gender Division of Labour, Theories of Care, Gender Welfare Regimes, Cultural Studies on Food and Society.

She is currently teaching Courses on General Sociology and Sociology of Education (first level degree) and Families, Gender, Pluralism (master degree).

Since April 2015 she is member of the Academic Council of Viu (International Venice University in San Servolo Island), as representative of the University of Padua.

March 2012 – April 2016 she was member of the Administrative Council of the University.

October 2013- February 2014 she was member of the Scientific Committee of the National Interinstitutional Observatory on Gender Violence founded by the Italian Government, Department of Equal Opportunity.

She is among Italian scholars who have implemented Sociology of Family, Social Politics and Welfare Studies, and she promoted Women's and Gender Studies.

She is the Coordinator of a Research Group on Food, Culture and Society at the Ph.D. Program on Social Sciences, University of Padua, Department FISPPA.

1994-2011 she was involved in the anti-violence politics and in research projects at local and national level, mainly as responsible of Anti-Violence Centre of Venice and as promoter and scientific coordinator of the National Anti- violence Network of the Urban-Italia Cities and of a Regional project on Gender and Human Rights.

From May 2001 to April 2008 she was on leave from the University, being elected as MP in the Italian Parliament.

In 2006-2008 she was the Chairperson of Chamber of Deputies' Standing Committee for the European Union Affairs.

In June 1999 she represented the Italian Government, as expert member, in the UN Committee preparing the twenty-first special session of General Assembly assessing the results of the Action Programme from the International Cairo Conference on "Population and Development".

1996-1999 she was the first Deputy Rector for "Equal Opportunities and Gender Studies" at University of Padua.
