

Amendment Notice INM-AR-001-2024-GE prot. 78442 dated 7/3/2024: Replacing art.3(a) of the English version

THE DIRECTOR

**Having regard** to Article 22 of Law No. 240 of 30 December 2010, as integrated by Legislative Decree No. 76 of 2020, converted into Law No. 120 of 11 September 2020;

**Having regard** to the Regulations on the organization and functioning of the CNR, issued with CNR Presidential Provision No. 14/2019, protocol No. 12030 of 19/2/2019, which entered into force on 1/3/2019;

**Having regard** to the Disciplinary Regulations for the granting of research grants by the CNR, approved by the Board of Directors with resolution No. 28 of 9 February 2011 and subsequently modified by resolutions No. 62 of 23 March 2011, No. 186 of 22 September 2011, and No. 189 of 27 November 2013;

**Having regard** to the measure of the Director General No. 8/2024, protocol No. 25595 of 26 January 2024, entitled "Mr. Alessandro Iafrati – Appointment as Director of the Institute of Marine Engineering (INM) – Rome";

**Having regard** to the selection notice INM-AR-001-2024-GE protocol No. 78442 of 7/3/2024;

**NOTING** that the English version erroneously indicates in Article 3 and in ANNEX A letter a) "Bachelor's" instead of "Master's degree";

**DETERMINED** the need to provide;

DISPOSES

1. At the Article 3 letter a) of the English version of notice INM-AR-001-2024-GE protocol No. 78442 of 7/3/2024 is hereby replaced as follows:

a) Master's degree in one of the following:

For degrees obtained abroad, non-academic recognition is required according to the procedure provided for in Article 38 of Legislative Decree 165/2001, with the modalities set out in Article 2 of DPR 189/2009, as amended by Article 1, paragraph 28-quinquies of Law 15/2022. The candidate who has not yet obtained the recognition of the foreign academic degree must declare in the application form to have submitted the relevant request. In this case, the candidate will be admitted to the selection with a reservation, provided that this provision must be presented before the signing of the employment contract.
