TERMS AND CONDITIONS

1. **Scope:** The purpose of these general purchasing conditions is to uniformly regulate the contractual relationships with suppliers from whom the CNR purchases goods and/or services in the application of laws and regulations. The supplier's terms and conditions of sale shall in no case be applicable to contractual relations with the CNR, even if they had referred to in any document from the supplier.
2. **Yield:** Freight - free.
3. **Invoicing:** The invoice, drawn up in accordance with current regulations, must include, under penalty of rejection of the invoice, the order number (corresponding to the reference number), the CIG and the CUP, if any.
4. **Payment:** Payment will be made within 30 days from the date of the performance certificate.
5. **Traceability of financial flows:** the supplier assumes all obligations of traceability of financial flows under Article 3, Law 136/2010 amended. Failure to use bank or postal transfer or other collection or payment instruments suitable to allow full traceability transactions constitutes grounds for unilateral termination of the contract. The s.m.i. and to give immediate notice of default of its counterparty (subcontractor/subcontractor) to the financial tracking obligations.
6. **[For orders less than 40.000 euros] Express termination clause:** The order è issued pursuant to the provisions contained in Art. 18, , c. 1, lett. a) of Legislative Decree 36/2023. The CNR has the right to terminate the contract/order in the event of. Establishment of the lack of participation requirements. Article 122 of Legislative Decree 36/2023, as well as articles to the supplier, with the prohibition of payment of consideration, except to the extent of services already performed.
7. **Jurisdiction:** The court of Rome shall have exclusive jurisdiction in any dispute.
