- 1. - 2. Billing:** The invoice, drawn up according to current Italian legislation, must include, under penalty of rejection, the order number and the CIG.
- 3. Payment:** Payment will be made within 30 days starting from the date of the certificate of regular execution.
- 4. Traceability of financial flows:** The supplier assumes all the traceability obligations of the financial flows referred to in the art. 3 of Italian Law 136/2010 and subsequent amendments. Failure to use the bank or postal transfer or other collection or payment instruments suitable to allow full traceability of the operations constitutes grounds for unilateral termination of the contract.
