



NOTICE OF EXPRESSION OF INTEREST PURSUANT TO ART. 11 OF THE REGULATION GOVERNING RESEARCH ASSIGNMENTS APPROVED BY RESOLUTION NO. 169/2025 OF 30.09.2025 OF THE BOARD OF DIRECTORS AIMED AT THE DIRECT ASSIGNMENT OF A RESEARCH ASSIGNMENT PURSUANT TO ARTICLE 22-TER OF LAW NO. 240 OF 30 DECEMBER 2010

The Institute of Biochemistry and Cell Biology of the National Research Council (IBBC -CNR), in the person of the Director Dr. Anna Moles, with registered office in Rome, Piazzale Aldo Moro n.7, with headquarters in Naples, at Via Pietro Castellino n.111 and secondary office in Via E. Ramarini n. 32 00015 Monterotondo Scalo (Rome)

HAVING REGARD to the Regulation governing research assignments TITLE III – Direct award procedures Article 11 which states: "*Without prejudice to the provisions of Title II of these regulations on selection procedures, which constitute the ordinary selection procedure, for research assignments financed by external resources, obtained at national, international or European level, on the basis of competitive calls, the Institute Director/Department Director/Head of the Interdepartmental Centre, may provide for direct award procedures, through notices published on the National Recruitment Portal <https://www.inpa.gov.it>, on the Institutional website of the National Research Council, <https://www.urp.cnr.it>, in the CNR <https://selezionionline.cnr.it> Online Selection System, on the European Union portal (<https://euraxess.ec.europa.eu/>) and on the website of the Ministry of University and Research, for the purpose of collecting expressions of interest from candidates.*"

CONSIDERING that the National Research Council, in the interest of the Institute of Biochemistry and Cell Biology, has signed with the European Commission the *Grant Agreement* no. 101072505 relating to the implementation of the *Horizon Europe Marie Skłodowska - Curie Action Doctoral Network 2021* entitled: "*Cohesin and its regulators: from chromosome dynamics and nuclear architecture to human diseases*" (acronym: CohesiNet);

WHEREAS *Grant Agreement* no. 101072505 provides for the provision of a *fellowship* to a *Doctoral Candidate* to be carried out at the Institute of Biochemistry and Cell Biology, as part of the *Marie Skłodowska - Curie Action Doctoral Network 2021 CohesiNet* program;

CONSIDERING the publication of the Network <https://euraxess.ec.europa.eu/jobs/66353>, which in implementation of the above, the IBBC-CNR, Naples office, has announced the assignment of two positions for *Doctoral Candidates*, with prot. act no. 198934 of 28.06.2023, to be recruited at the Naples office, which led to the awarding of Grant-type research grants pursuant to art. 22 of Law no. 240 of 30.10.2010;



CONSIDERING that, at present, there are **14 months** of *fellowship remaining* according to the *Grant Agreement* no. 101072505 stipulated with the European Commission for the implementation of the *Horizon Europe project - MSCA Doctoral Network CohesiNet*;

HAVING REGARD to the request received by prot. no. 428307 of 31.10.2025 from Dr- Francesca Maria Pisani, Coordinator of *Horizon Europe - MSCA Doctoral Network CohesiNet*, to activate the direct assignment procedure *pursuant* to Article 11 of the Disciplinary Regulations for the assignment of research assignments pursuant to Article 22-ter of Law No. 240 of 30 December 2010 and consequent determinations adopted by the Board on 30 September 2025 with resolution no. 169/2015 and the positive opinion expressed by Dr Alexandra Kruch, *EC-REA Project Officer* of the aforementioned CohesiNet project, to the reopening of the position of *Doctoral Candidate* at the IBBC-CNR (Naples office) for the duration referred to above;

HAVING REGARD to the communication made by the Director of the IBBC-CNR to the Director of the Department of Biomedical Sciences with protocol act no. 428670 of 31.10.2025 initiating the direct assignment procedure pursuant to art. 11, paragraph 2 of the aforementioned Disciplinary Regulations;

HAVING REGARD to the need and urgency to provide for the filling of the vacant position and the assignment to another potential available candidate, with a scientific-professional profile suitable for carrying out the project, in order to ensure the continuation of the experimental activities envisaged by the research program and to safeguard the implementation of the project within the scheduled deadlines;

WARN

that the IBBC-CNR (Naples office) intends to confer a *fellowship position* with the announcement of an Expression of Interest for the search for a *Doctoral Candidate* to carry out the activities envisaged by the *Horizon Europe project - MSCA Doctoral Network CohesiNet* (**title: "Cohesin and its regulators: from chromosome dynamics and nuclear architecture to human diseases" - CUPB63C23000420006**) according to the provisions of *Grant Agreement* no. 101072505 and the *Annexes*, under the supervision of Dr- Francesca Maria Pisani, Project Coordinator.

REQUIREMENTS

- *Master's Degree* in Biology, Biotechnology, Biochemistry, Molecular Biology, Medicine, Molecular Medicine and related degrees;
- Not in possession of the PhD degree;
- *Professional curriculum* suitable for carrying out research activities, dated and signed;
- Not be resident or have not carried out main activity (study, work, etc.) for more than 12 months in the last three years in Italy.



DURATION OF THE CONTRACT

The research assignment will have a total duration of **14 months** and its disbursement will be automatically terminated at the end of the deadline.

PLACE OF THE ACTIVITY

The activity must be carried out at the IBBC – CNR (Naples office), via Pietro Castellino n. 111 c/o Naples Research Area 1.

ECONOMIC TREATMENT AND PAYMENT METHODS

The residual amount of the remuneration for the *Doctoral Candidate*, established by the G.A. Annex II is equal to:

- € 3,171.17 gross gross monthly receipt, net of social security withholdings, of which € 3,311.60 for *living allowance* and € 600.00 for *mobility allowance*, gross of tax, social security and insurance withholdings.

The fee will be paid in deferred monthly installments by crediting the bank account indicated.

The remuneration of the research assignments awarded under the MSCA-DN actions is determined by the reference MSCA Work Programme and the Grant Agreement and its annexes.

The provisions of Article 4 of Law No. 476 of 1984 on social security, the provisions of Article 2, paragraphs 26 et seq., of Law No. 335 of 1995, on compulsory maternity leave, the provisions of the Decree of the Minister of Labour and Social Security of 12 July 2007 shall apply to research assignments. and, in the matter of sick leave, Article 1, paragraph 788, of Law No. 296 of 2006. In the period

of compulsory maternity leave, the allowance paid by the National Social Security Institute (INPS) pursuant to Article 5 of the aforementioned Decree of 12 July 2007 is supplemented by the Institution up to the full amount of the remuneration for the research assignment.

The Research Associate for the performance of the activity related to the assignment in question will not be allowed to receive any other remuneration or the end-of-service indemnity at the end of the relationship for the performance of the research project.

The ownership of the position does not give any right to access the roles of the Entity, nor can it be computed for the purposes of Article 20 of Legislative Decree No. 75 of 2017.

Requests for Expressions of Interest produced in a manner other than that provided for will not be taken into consideration.

The application must be accompanied by:

- CV, entering all the information, both substantive and formal, relating to the qualifications that you intend to submit to the evaluation of the examining committee;
- *Master's degree certificate*;
- candidates who have obtained a degree from a foreign university may attach to the application the provision of academic recognition of the qualification issued by an Italian university according to current legislation;
- valid identification document.

The IBBC-CNR reserves the right to suspend, modify or cancel, in whole or in part, the procedure initiated if it deems it appropriate. In this case, the subjects who have submitted expressions of interest will not be able to claim any claim in relation to the procedure initiated.

The personal data that IBBC-CNR will come into possession of as a result of this procedure will be processed in compliance with Legislative Decree 196/2003, as amended by EU Regulation GDPR 2016/679. According to the aforementioned legislation, this processing will be based on the principles of correctness, lawfulness and transparency and protection of the confidentiality and rights of the proponents.
